with camping on site and wonderful pot luck style BBQ on Saturday night. This event has been getting bigger and better each year. If you are looking for something to do especially Saturday I suggest this float fly. Even if you don't have a float plane just pack a cooler with some drinks and snacks then grab your favorite folding chair and come up. With all the grass and shade just toss your chair out and plunk down the cooler next to it and spend the day watching the planes, visiting with members and maybe even the occasional nap in the afternoons warmth. This year as discussed at the last club meeting they are having some fun with Spitfires on floats. Several of the guys have been buying Dynam Models 1.2m foam Spitfires to race and have fun with. John Eaton actually bought one at the last meeting during the conversation. I think John said his was \$179 as a plug n' play. Just add your RX and flight battery. John's arrived just before the last indoor so he brought for us to see. Over the course of the evening he had it basically assembled before he went home. So should be interesting to see a bunch of identical Spitfires chasing around after each other. Our next event at the field will be the Burgdorf Memorial Pylon race on the weekend of May 19 & 20. Robert Holik CD's this event for us and he is looking for help. Last year this event was scrubbed due to the field not being usable due to the winter damage. So Robert has lost the momentum of some if his workers. Not a lot of WDA members are pylon racers, which means there should be plenty of us to help out and lend a hand. This event tends to be one of the more prosperous events we hold but it also takes some effort on our part to bring the necessary man power to pull it off. If you have time that weekend please contact Robert to lend a hand. As I recall in a perfect world we would love to see about 15-20 people around the site each day to both help and give others breaks.

Last I wanted to touch on what the board has been doing over the last several months discussing the status and vison for the equipment needed to maintain the field. We have been operating for years on riding mowers most of the residential nature. These mowers were either purchased used or were donated to the club. Most of the time they just do not stand up to the rigors of the "duty cycle" at our flying field. Our old equipment was just getting to the point we were putting a lot of man hours and \$\$ into maintenance vs. operating time. So during the 2016 mowing season we elected to try a new approach and purchased a new 66" commercial pull behind

mowing deck. This is a deck that has its own dedicated engine that runs just the mowing blades on the deck. This concept had its advantages and disadvantages. But for our use we felt it was a better fit. Like most things that deck had some growing pains mainly associated with the belts, but we have sorted that out and it is working quite well for us now. That deck has become the primary means of how we mow the bulk of the field week in and week out. We still have a couple small riding mowers for doing the detail work around the site. Then late last year we started to look at the totality of how our operations were working and how we could better help the volunteers that maintain the field for us all. It was decided since we had access to an electric golf cart to give it a shot for pulling that deck around the field instead of a ride around mower. We now have that in operation working at the field. It still early in the evaluation process but things are looking positive so far. The board is now looking at phasing the next couple of steps out due to the cost involved. The next step probably in the next couple month will likely be the purchase of another identical pull behind mower deck. This would double our mow capacity under normal circumstances and give us the security if one deck goes down we still have one that would be operating. By purchasing the same pull deck we also know what we're getting and it makes it easier for maintain identical equipment. A luxury we have not had in the past. The next step will be the purchase of a "Commercial" ride around mower. To replace some of the residential units we are using for doing that detail work and could once again expand our cutting production as well. This purchase will not happen right away. But will rather be dictated by available funds and opportunities that present themselves. We have a good relationship with the local John Deere dealer that we have been dealing with for years. We may plant the bug in their ear in case they come upon a good deal or good trade in. I wanted to pass this on for a couple reasons one so that you know where your membership dollars are being spent since these both will be a substantial purchases. But to also plant the bug in everyone's ears to keep an eye out for opportunities on a commercial grade mower preferably John Deere since that is what we mainly operate.

Well, that's it for this month gang. Looking forward to great flying weather ahead! Hope to see you at the field.

Meeting called to order at 1914 hours by Forrest Barton. at the Woodland Public Library. There were 16 members present plus one guest/potential new member. A motion was made by Art Williams to approve last month's minutes, seconded and passed.

### **Officer reports:**

**President:** Forrest deferred until the "business" portion of the meeting.

<u>Vice President:</u> Doug Vice reported that the golf cart issue is closed, we have sprinklers heads, work party to be scheduled and we are looking at mowers.

**Treasurer/Membership:** John Eaton gave a two month treasurer's report. He cannot account for member card number 18031. If you have it please let him know. We have 83 paid up members so far.

Secretary: Mike's only comment was that Carlos is still listed as an instructor and we need to find out his status. Safety: John Lett was absent.

#### Chair reports:

Instead of being laser cut, the parts are CNC router cut to eliminate the burnt edges a normal laser cut kit possesses. It has a three piece wing with a full flying stabilizer. Lou plans to cover it with UltraCote Lite. Lou estimates it should be 15 ounces all up. ## Bankruptcy judge OKs Horizon's purchase of Hobbico's RC business

CHAMPAIGN — A bankruptcy court judge approved Horizon Hobby's \$18.8 million purchase of Hobbico's remotecontrol business Monday, which means Hobbico employees must reapply for their jobs at Horizon before the purchase is completed Friday.

Hobbico's more than 300 employees were made aware of this possibility last week, after Horizon was the lone bidder in a bankruptcy auction for Hobbico, which filed for Chapter 11 protection in January with the goal of finding a new buyer.

"As mentioned in yesterday's Town Hall Meetings, Hobbico employees who are interested in being considered to work at Horizon Hobby are required to apply online," Hobbico human resources manager Megan Huppert wrote Friday in an email obtained by The News-Gazette.

It's not clear how many of the employees will be hired at Horizon, especially since the two Champaign-based hobbyproduct distributors perform similar tasks.

"Horizon and Hobbico have served many of the same retailers and customers for years," Horizon CEO Joe Ambrose said when his company announced it would try to buy Hobbico's RC units.

Horizon is buying Hobbico's Great Planes and Tower Hobbies divisions, along with its Axial and Arrma brands. Also on Monday, a bankruptcy judge approved a separate \$7 million sale of Hobbico's Colorado-based model-rocket subsidiary, Estes, to an organization called The Langford Group.

An auction for Hobbico's remaining assets - including United Model, Revell US and Revell Germany - was tempo-

rarily suspended last week.

Hobbico employees will be applying for jobs in departments at Horizon rather than specific positions, and a temp agency is helping Horizon process the applications.

"Due to time constraints with hiring/reviewing/interviewing 300+ employees, Express Employment is assisting Horizon with the recruitment process," Huppert wrote. "Employees who are selected to work in the Distribution Center could start on Saturday, April 7th through Express Employment."

If employees apply by Friday, their seniority with Hobbico will be used to determine when they're eligible for benefits.

However, "If you apply after the close of the transaction (April 6th), you would be considered a new applicant and treated like any other external candidate," according to a document attached to Huppert's email.

"We will review the applications and get in touch with candidates with whom we are interested in moving forward," the document said, later saying: "We plan to interview as many people as we can, but given the short time frame prior to closing, we will not likely be able to interview everyone."

A representative for Hobbico could not be reached for comment Monday, and a representative for Horizon said the company would issue a statement after the sale closes.

The two companies were both formed in 1985 and are among the top 25 employers in the county, according to the Champaign County Economic Development Corp.

Last year, Hobbico said it employs 415 people in the county, and Horizon Hobby reported 341 employees.

## FAA Authorization Extended to September 30, 2018

The AMA Government Affairs team has worked diligently with Congress to ensure our hobby is protected in Federal Aviation Administration (FAA) reauthorization legislation. On March 23, President Trump signed the omnibus spending bill into law, which includes a six-month extension of FAA authorization, funding the FAA through September 30, 2018. This extension means the Special Rule for Model Aircraft (Section 336) will remain intact and our members can continue to fly under AMA's set of community-based safety guidelines, as we have for many decades.

While this legislation provides short-term clarity for our members, we need long-lasting certainty for our hobby. Over the next six months, we will continue to work with Congress on a long-term reauthorization bill that will strengthen the Special Rule for Model Aircraft and affirm the role of community-based organizations like AMA in educating and supporting hobbyists.




