Nature of Hazard: I did not directly view this event. It has been described to me by one of the pilots involved. A pilot left his pilots station, walked across the runway at the conclusion of his flight and retrieved his electric powered model. By multiple accounts no audible request to take the runway was heard. While the pilot was retrieving the model, a second pilot flying an electric ducted fan jet was performing a fly by at low altitude (6-10 feet). The path of the aircraft in the fly by and the modeler retrieving his aircraft nearly coincided.			
Initial Actions and/or Recommendations: Pilot of electric ducted fan talked to me about the incident and reported what he saw. He was visibly bothered by the incident. He did have a spotter present. The other pilot left promptly before I could speak to him. It does not appear that he was aware of the potential hazard. There was no spotter for this pilot.			
Recommendations: Pilot of model on runway failed to broadcast his intent to walk onto the runway and failed to utilize a spotter. Pilot of electric ducted fan jet on low pass did not look ahead and abort low pass. Spotter did not look ahead and aid pilot to abort low pass. Pilot of ducted fan jet possibly was over the runway surface for his low pass. Maneuvers should all be performed beyond the black mat runway surface.
